

GENERAL MEETING

THE GENERAL MEETING ON FEBRUARY 2 IN UTAH POWER AND LIGHT CO. AUDITORIU, ON WEST NORTH TEMPLE WAS WELL ATTENDED. THE TOTAL MEMBERS PRESENT WERE ABOUT 50, OF WHOM 33 WERE ELIGIBLE TO VOTE. THUS, NEARLY ONE-THIRD OF THE VOTING MEMBERSHIP WAS PRESENT, A GREAT IMPROVEMENT OVER SOME MEETINGS IN PREVIOUS YEARS WHEN ACTION HAS BEEN TAKEN WITH LESS THAN HALF AS MANY VOTING MEMBERS PRESENT.

President Harold Goodro presided and presented the proposed amendments, which had been mailed with the meeting announcement to all members on January 23rd.

THERE WAS AT LEAST SOME DISCUSSION ON EVERY PROPOSAL, AND PROBABLY HALF A DOZEN MEMBERS SPOKE ON SOME OF THE MORE CONTROVERSIAL AMENDMENTS.

AFTER THE CONCLUSION OF THE DISCUSSION, ALL ELIGIBLE MEMBERS SUB-MITTED WRITTEN BALLOTS ON THE TWELVE RPOPOSED AMENDMENTS.

SINCE A TWO-THIRDS VOTE IN FAVOR OF ADOPTION IS REQUIRED FOR A CONSTITUTIONAL AMENDMENT, 22 FAVORABLE BALLOTS WERE REQUIRED IN THIS ELECTION.

THE RESULTS OF THE BALLOTING, WITH PROPOSED AMENDMENTS LISTED IN THE ORDER GIVEN WITH THE MEETING ANNOUNCEMENT, WAS AS FOLLOWS:

ITEM A, TO CHANGE ELIGIBILITY REQUIREMENT FOR MEMBERSHIP ON THE BOARD OF DIRECTORS.

YES - 18, No. 15 DEFEATED.

ITEM B, TO SPECIFICALLY INCLUDE THE TRUSTEES AMONG THOSE CONTROLLING THE BUSINESS AND ACTIVITIES OF THE CLUB.

YES - 29, No. - 4. ADOPTED.

ITEM C, HAVING THE PRESIDENT ELECTED AT THE GENERAL MEMBERSHIP MEETING.

YES - 18, No - 15. DEFEATED

ITEM D, PROVIDING THAT NO DIRECTOR SHALL SERVE AS TREASURER FOR TWO CONSECUTIVE TERMS.
